1 Interpretation

Equipment

Holiday

means the dates given to us by You when requesting the Equipment

Replacement Fee

means the sum of £ 1900 excluding VAT

Return Period

means not more than two weeks from the end of your Holiday but in any event within 12 months of the date of this Agreement



2 Agreement

- (a) We agree to loan the Equipment to You for your Holiday subject always to the following matters and you hereby agree that:
 - (i) If You lose, destroy or damage the Equipment;
 - (ii) If the Equipment is returned to us in a used condition or is programmed with any data.
 - (iii) If You do not return the Equipment to us in the provided envelope by the Return Period; You will pay to us the Replacement Fee on demand.
- (b) If You use the Equipment because your existing mylife™ Ypsomed Pump® insulin infusion pump has a defect of mechanical error and cannot be reset then we will not demand payment of the Replacement Fee.

3 Title

You acknowledge that:

- (a) we will at all times retain the ownership of the Equipment; and
- (b) You will have no right of ownership in the Equipment;

4 Excluding liability

We do not exclude our liability for death or personal injury caused by our negligence or breach of our duties under the law, fraud or fraudulent misrepresentation. Subject to this, we are not liable for (i) loss which was not reasonably foreseeable to both You and us at the time when the Contract was made, or (ii) loss which relates to your business, trade, craft or profession to the extent that it would not be suffered by a buyer who is a Consumer. This is because we believe that You are not using the Equipment wholly or mainly for the purposes of your business, trade, craft or profession.

5 Governing law, jurisdiction, complaints and codes

This Contract will be governed by the law of England and Wales.
